ENTRANCE PORCH

The property offers excellent potential and would benefit from a programme of modernisation throughout, allowing purchasers the opportunity to create a home tailored to the buyers own taste and style. A welcoming front porch featuring large leaded double-glazed side panels and a matching glazed UPVC entrance door, allowing plenty of natural light to enter. Finished with laminate flooring and painted brickwork, the space offers an inviting first impression and leads through to the main hallway.

HALLWAY

The hallway is fitted with wood-effect flooring and benefits from an electric radiator and central ceiling light point. Doors lead to all principal rooms, including a glazed door to the primary bedroom, a solid door to the second bedroom, and a useful storage cupboard. Partially obscure glazed doors provide access to both the lounge and the open-plan kitchen/dining area, allowing light to flow while maintaining separation.

LOUNGE

The lounge is a bright and generously proportioned room, featuring two large windows to the front and side elevations that allow plenty of natural light to flow in. A decorative feature fireplace adds character, complemented by wall and ceiling light fittings for flexible lighting. Finished with wood-effect flooring and an electric radiator, the room offers a warm and welcoming feel. Alternatively, this versatile space could be used as a third bedroom, depending on the buyer's needs.

OPEN PLAN KITCHEN DINING ROOM

KITCHEN

The kitchen is fitted with a selection of wall, base, and drawer units, offering practical storage and functionality. Roll-top work surfaces and a one-and-a-half bowl sink with drainer and mixer tap complete the layout. A large rear-facing window allows for plenty of natural light, with an additional obscure glazed window to the side. There is space and plumbing for a freestanding oven and hob, washing machine, and upright fridge freezer. The room also benefits from spot lighting, an extractor fan, and lino flooring.

DINING ROOM

Open plan to the kitchen, the dining area offers a practical and adaptable space for family meals or entertaining. A window to the side elevation provides additional daylight, while wall and ceiling light points ensure good illumination. Carpeted flooring and an electric radiator complete this inviting area, which benefits from a part obscure glazed door leading to the rear porch.

REAR PORCH

The rear porch benefits from glazed and obscure glazed windows to two aspects, admitting daylight while maintaining privacy. Finished with laminate flooring, the porch offers a useful area with an obscure glazed door providing rear access.

BEDROOM ONE

The primary bedroom features a large window to the front elevation, flooding the room with natural light. Finished with wood-effect flooring and a central ceiling light point, it offers a bright and comfortable space.

BEDROOM TWO

Bedroom two features a window to the side elevation, providing ample daylight and ventilation. The room benefits from wood-effect flooring, an electric radiator, and a central ceiling light point, offering a flexible space suitable for various uses.

FAMILY BATH AND SHOWER ROOM

This spacious bathroom includes a WC, wash basin set into a vanity storage unit, and a panelled bath. There is also a separate shower enclosure with a wall-mounted electric shower and screen door. An obscure glazed window to the rear elevation provides privacy while admitting daylight. The room features lino flooring, part-tiled walls, spotlights, an extractor fan, and loft hatch access.

GARAGE AND DRIVE

Accessed via an iron cast gate, the driveway provides off-road parking for one car and is surrounded by mature shrubs and planting, enhancing the property's kerb appeal. This leads to the under-house garage, which features an up-and-over door, as well as power and lighting.

OUTSIDE

To the front and side of the property is a garden predominantly laid to lawn, featuring a paved pathway leading to the front entrance door and a paved entrance area. The garden is bordered by hedging, with steps leading down to the driveway and garage access.

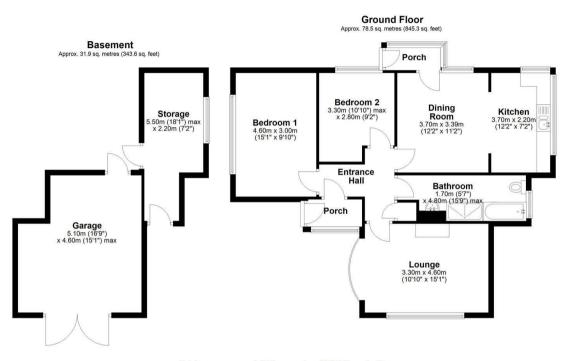
